The European Commission today decided to impose provisional anti-dumping dutieson imports of solar panels and key components (i.e. cells and wafers) from China. An investigation found that a Chinese solar panel is sold to Europe far below its normal market value.

On the basis of these findings, it has been decided to impose an anti-dumping dutyin a two-staged process: for two months, a duty of 11.8% will have to be paid, whereas from 6 August, duties ranging from 37.3% to 67.9% (averaging 47.6%) will be levied on solar panels from China.

What anti-dumping complaints has the European Commission received?

In terms of import value affected, this is the most significant anti-dumping complaint the European Commission has received so far: in 2011, China exported solar panels and their key components worth around EUR21 billion to the EU.

An anti-dumping measure is imposed, usually in response to a complaint, on specific goods from a specific country. Think for example of the measures that were imposed by the EU against solar panels and cells from China or measures against light thermal paper from Korea. China, however, is the "usual suspect" in anti-dumping cases.
