Is revenue a materiality benchmark?

The Group is in a loss making position and focused on expanding revenue. Revenue is considered to be an appropriate materiality benchmarkand constitutes a key performance measure. Given the nature of business activity, a lower level of performance materiality was considered appropriate.

Can energy storage enhance integration of renewables?

Which share plan remains outstanding at 31 December 2023?

The primary share plan that remains outstanding at 31 December 2023 is the 2018 plan. The 2018 plan was adopted by the Board on 14 May 2018 and introduced HMRC scheme rules related to certain non-taxable option grants. The plan contains a provision to issue options as CSOP,EMI or unapproved awards.

Is tax based on a Consolidated Statement of profit & loss?

Taxation is recognised in the consolidated statement of profit and lossexcept to the extent that it relates to a business combination or items recognised directly in equity or other comprehensive income. The current tax charge is based on the taxable profit for the year.
