#### Does FedEx ship lithium batteries?

FedEx adheres to IATA regulations for shipping lithium batteries by air and ADR regulations for shipping lithium batteries by road in Europe. Regulations on how to ship lithium batteries vary depending on which type you are shipping. Typically found in watches and cameras, they contain metallic lithium and are also called primary lithium batteries.

#### Do I need a class 9 lithium battery label?

The Class 9 Lithium Battery label (IATA Figure 7.3.X) is required all Section I,IA,and IB shipments. The phone number will be optional to include on the label effective 1/1/23. Note: No text is allowed on the bottom half of the label outside of the number "9."

#### When will lithium batteries be able to be shipped?

Beginning in 2022, the International Air Transport Association (IATA) has adopted some significant changes to shipping standalone lithium batteries. These changes will take effect beginning January 1,2022. However, there is a grace period that will be extended out until March 30,2022 before 100% compliance is required.

### What are the shipping requirements for a lithium ion battery?

All packages prepared in accordance with Packing Instruction 968,Section IA,IB and II,must bear a Cargo Aircraft Only label,in addition to other required marks and/or labels. All lithium ion cells and batteries (UN 3480 only) must be shipped at a state of charge (SoC) not exceeding 30% of their rated capacity.

#### What is a regulated battery shipment?

Some dry batteriesare regulated battery shipments (Class 4 -- Dangerous When Wet or Class 8 -- Corrosive) and must be correctly identified, classified, packaged, marked and labeled. Position multiple batteries or packages of batteries side by side, separated by dividers.

#### How many lithium batteries per package?

Section IB: Less than 2 gram of lithium metal per battery but more than 2 batteriesper package. No need to use DG package, but still need to issue DGD, and stick labels of Class 9, lithium battery, and cargo aircraft only if by airfreight. Battery weight of each package cannot exceed 2.5KGS.
