Can a software license be sold on a secondary market?

It is permissible to sell on the secondary market of software with resale rights OEM licenses with hardware included, physical licenses... On the other hand, it is forbidden to sell software licenses that are leased, subscriptions to cloud licenses (SaaS) and service contracts attached to software licenses.

What is a sale of electronically supplied software?

Accordingly, the ECJ found that a sale of electronically supplied software, where that sale includes the granting of a licence, is a sale of goodswithin the meaning of the Directive. The ECJ also found that this conclusion was consistent with the spirit of the Directive.

Does a sale include a licence to use the software?

The ECJ determined that, therefore, a sale must include a granting of a licence to use the software. On examining the exclusions identified by the Directive, the ECJ considered that none of them applied to this dispute.

Any behavior that appears to violate End user license agreements, including providing product keys or links to pirated software. Unsolicited bulk mail or bulk advertising Any link to or advocacy of virus, spyware, malware, or phishing sites.

The engineers here have developed a software package they want to deploy on servers we sell. This software package is built on the Microsoft Server 2012 operating system. I know that the engineers used an MSDN account to acquire the server 2012 Operating system install. Is it legal to sell the 2012 OS that was acquired through an MSDN account?

As a result software licenses adapted and started to expressly sell the license as a license to obtain the service of a maintained software.
