How long do lead-acid batteries last?

According to a 2019 study by the Battery Council International, premium lead-acid batteries can last over 6 yearswith proper maintenance. This durability stems from the use of advanced manufacturing techniques and superior lead-alloy materials. Examples include brands like Optima and DieHard, which are known for their long-lasting products.

What is the warranty on Exide Batteries?

The label on every Exide battery specifies the total number of months covered by the free replacement period and the Pro-Rata period for batteries fitted in private cars, multi-utility vehicles\*, two-wheelers, inverters, gensets and solar applications. In all cases the warranty is applicable from the date of sale to the original purchaser.

Are lead acid batteries toxic?

What is the design life of a lead acid battery?

The Eurobat Guide for the Specification of Valve Regulated Lead-Acid Stationary Cells and Batteries defines design life as follows: "The design life is the estimated life determined under laboratory conditions, and is quoted at 20°C using the manufacturer's recommended float voltage conditions." 6
